 - measurable benefits to improvements in any/all of the following physical and mental health, workplace culture, employee productivity, absenteeism, presenteeism, efficiency
 - any noticeable changes in employee attitudes and or behaviours towards health and wellbeing
- Self-nominations for 'individual' recipients <u>not</u> accepted.
- Each nomination criteria must be addressed in the application.

Selection Criteria

- Provide a snapshot of the nominated Company or Individual including:
 - o company profile, relevant achievements and skills and abilities (for Individual).
- Provide details of the program or initiative including:
 - Description of the program/initiative and why it was implemented
 - How the program/initiative was implemented and how employees were engaged in the program
 - Uptake by employees and impact on business and employees
 - Any direct or indirect benefits to employees and workplace
 - Plans to continue or expand the program/initiative
