

NOMINATIONS CLOSE - 1 AUGUST 2025

The Queensland Trucking Association Road Freight Industry Awards are the industry's gala event of the year. The Awards recognise the outstanding calibre of people, businesses and initiatives that make up the road freight industry in Queensland.

Any financial member of the Queensland Trucking Association may nominate. This includes an individual, business or initiative, providing they meet the relevant Award Criteria.

A judging panel, appointed by the Association, will examine the nominations according to the Selection Criteria. Nominees are reminded to address each of the Award Criteria for the judges consideration.*

Nominees who have been shortlisted for their category will be notified by email and are encouraged to attend the Road Freight Industry Awards night on Saturday, 13 September.

Nomination Eligibility

- Full-time professional road freight drivers or owner/operators based in Queensland (nominee must be employed by a QTA member).
- A minimum of 7 years experience as a driver.
- An exemplary driving record with a demonstrated focus on safety.
- Self-nominations are not accepted.
- Each nomination criteria must be addressed in the application.

- Career History list each employer including years served and positions held.
- Demonstrate a high degree of pride in their personal presentation and their vehicles presentation.
- Demonstrate a high degree of skill and experience in freight handling relevant to their field.
- Demonstrate a professional attitude towards their job, their customers and the industry as a whole.
- Demonstrate a strong interest in a safe professional image of the industry. e.g. undertaking continuous training, use of safety technology, driver training/mentoring.

Nominations must to be accompanied by the below supporting documentation:

- High quality, electronic photograph (jpg, png format) suitable for promotional purpose.
- Two signed references (2) in the form of formal letters of support for the nominee with the name, business name and contact details of the referee(s).
- Current road agency traffic record.
- · Certificate qualifications, licences, skill sets completed
- Any periods of incident free driving (kilometres travelled/length of time)


