 - Safety demonstrated leadership from an individual or an initiative, campaign, product or process influencing drivers, employees and/or operators to improve and maintain standards of safety.
 - Innovation demonstrated leadership to design, develop, implement a product or initiative to improve efficiency, productivity, health & wellbeing or environmental impacts within their company or the broader industry.
- Self-nominations for 'individual' recipients not accepted.
- Each nomination criteria must be addressed in the application.

Selection Criteria

- Provide a snapshot of the nominated Company or Individual including the history (for company), relevant achievements and skills and abilities (for Individual).
- Provide details of the initiative or innovation.
- Provide details of when the initiative or innovation was implemented and the reason for implementing.
- Provide details of how the initiative or innovation was implemented, other parties involved, barriers/challenges faced during this process and how they were overcome.
- Describe the impact of the initiative or innovation on your business/staff.
- Describe the most rewarding part of the initiative or innovation.




