Nominees who have been shortlisted for their category will be notified by email and are encouraged to attend the Road Freight Industry Awards night on Saturday, 13 September.

Nomination Eligibility

- A Company or Individual that has demonstrated leadership in a Training and Skilling program or initiative (Company or Individuals employer company must be a QTA member).
- Each nomination criteria must be addressed in the application.

Selection Criteria

- Provide a snapshot of the nominated Company or Individual including the history (Company), and the relevant achievements, skills and attributes (Individual).
- Describe the training program, purpose and when it started.
- Detail the training program's objectives and address the benefits of the program (eg: improves attraction and retention, workplace culture, workplace wellbeing, safety etc)
- Detail how the training program was implemented and the staff/stakeholders involved and the number/percentage of employees/contractors that have participated.
- What are the outcomes/benefits of the program including whether the program will be continued to be delivered?
- Demonstrate the positive effect of the program on the workforce.
- If possible, provide testimonials from staff on the benefits of the program and its impact.

Nominations must to be accompanied by the below supporting documentation:

- High quality, electronic Company Logo/Individual photograph (jpg or png format) suitable for promotional purpose.
- Two signed references (2) in the form of formal letters of support for the nominee with the name, business name and contact details of the referee(s).
- High quality, electronic photograph (jpg or png format) relevant to the program/initiative that can be used for promotional purpose.
- Any additional documents pertaining to the achievements, awards, honours which the nominee has received or the committee/industry groups the nominee has been involved in with direct relevance to the award.




