Nomination Eligibility

- Any person up to 30 years of age working in the road freight industry in Queensland (nominee must be employed by a QTA member).
- Self-nominations are <u>not</u> accepted.
- Each nomination criteria must be addressed in the application.

- Career History list each employer including years served and positions held.
- Tell us the story of how the applicant started in the industry and how they got to where they are now.
- Describe what makes them stand out as a young achiever in your organisation.
- List any significant experiences or achievements they have had.
- What role do you see this person having in the industry in the future?

Nominations must to be accompanied by the below <u>supporting documentation</u>:

- High quality, electronic photograph (jpg, png format) suitable for promotional purpose.
- Two signed references (2) in the form of formal letters of support for the nominee with the name, business name and contact details of the referee(s).
- CV including Certificate qualifications, licences, skills sets completed.
- Any additional documents pertaining to the achievements, awards, honours which the nominee has received or the committee/industry groups which the nominee has been involved in with direct relevance to the award.
